The responsibilities and tasks of the EURL are stated in Article 94 of Regulation (EU) 2017/625. The main activities are:




Follow-up on Campylobacter for AMR monitoring

- Monitoring of AMR in the EU is described in Commission Implementing decision (EU) 2020/1729.
- The current decision runs 2021-2027.
- A protocol 'Isolation, identification and storage of C. jejuni and/or C. coli for monitoring of AMR' is available on our website and recommended to be used for harmonization of the monitoring.
- The protocol has now been in use for four years (two years of sampling from pigs and calves and two years of sampling from chicken and turkey).
- Follow-up of application and data collected to evaluate the need for an update of the protocol.
- A questionnaire has been sent to all reporting officers of Reporting officers of the Scientific Network for Zoonoses Monitoring Data including officers of subgroup AMR.
- Data will be collected September-October 2025.




EURL training courses 2026

- Enumeration, detection and species identification of Campylobacter (ISO 10272)'. SVA February 2026.


 5 participants.

Proficiency tests 2026


Proficiency tests

- * PT 41: Enumeration and voluntary species identification of *Campylobacter* mandatory (matrix: cabbage)
 - Parallel validation of category 'fresh produce and fruits'
- * PT 42: Detection and species identification of *Campylobacter* voluntary (matrix: swabs)
- * PT 43: Whole genome sequencing of Campylobacter
 - Two parts: 1. sequencing quality 2. data analysis
- * PT registration: December-January (deadline 16 Jan)
- * Dates for send-off: 9 March
- * Last date to submit results: 13 April/1 June
- * Preliminary reports sent out in June/September
- * Final reports sent out before the end of 2026
